

TECHKON Loaner Equipment Agreement

This agreement is by and between Techkon USA, LLC hereinafter referred to as TECHKON and _____, hereinafter referred to as BORROWER. Whereas, TECHKON, as owner, agrees to lend the equipment described below to BORROWER while the BORROWER's equipment is being evaluated and/or repaired by TECHKON. Now, therefore, the parties agree as follows:

1. BORROWER will give equipment left in its custody the same care provided to similar property of its own, and shall return the equipment in as good as condition as received.
2. BORROWER shall be financially liable for damage done through its own negligence and agrees to pay the full purchase price of the equipment should damage be done to the equipment.
3. Should BORROWER decide to move forward with the repairs, they may continue to use the loaner instrument until their serviced unit is returned. Once BORROWER has received their serviced unit, they have a grace period of 5 business days to return the loaner instrument. Failure to do so will result in a \$500 fee on the 6th business day and each week thereafter until unit is received by Techkon.
4. After receiving repair estimate should BORROWER decide not to have their unit repaired, they will have a grace period of 5 business days from the date of receiving the cost estimate to return the loaner instrument. Failure to do so will result in a \$500 fee on the 6th business day and each week thereafter until unit is received by Techkon.
5. BORROWER shall not assign or transfer its interest nor delegate its obligation in this agreement. Equipment shall remain in the possession of BORROWER for the time specified in this agreement.
6. BORROWER shall return the equipment to TECHKON USA, LLC, 185 Centre St. Suite 101, Danvers, MA 01923. BORROWER is responsible for packaging and all return shipping costs.

THIS AGREEMENT CONSTITUTES THE ENTIRE AGREEMENT BETWEEN THE PARTIES. THERE ARE NO UNDERSTANDINGS, AGREEMENTS, OR REPRESENTATIONS, ORAL OR WRITTEN NOT SPECIFIED HEREIN REGARDING THIS AGREEMENT. NO AMENDMENT, CONSENT, OR WAIVER OF TERMS OF THIS AGREEMENT SHALL BIND EITHER PARTY UNLESS IN WRITING AND SIGNED BY ALL PARTIES. ANY SUCH AMENDMENT, CONSENT OR WAIVER SHALL BE EFFECTIVE ONLY IN THE SPECIFIC INSTANCE AND FOR THE SPECIFIC PURPOSE GIVEN. BORROWER, BY THE SIGNATURE BELOW OF ITS AUTHORIZED REPRESENTATIVE, ACKNOWLEDGES HAVING READ AND UNDERSTOOD THE AGREEMENT AND TO BE BOUND BY ITS TERMS AND CONDITIONS.
